**Due to the state of emergency and/or local disaster caused by the COVID-19 pandemic, the Board of Commissioners of Hays County Emergency Services District No. 9 may hold its meeting via telephone conference call because of the difficulty and risks of convening a quorum in one location. If initiated, the call will be broadcast at the meeting location and recorded as required by the Texas Open Meetings Act. 1. Call to order; establish quorum;
2. Public Comment; In accordance with the Texas Attorney General's opinion, any public comment that is made on an item that is not on the published final agenda will only be heard by the Board of Commissioners. No formal action, discussion, deliberation, nor comment will be made by the Board of Commissioners. Individual members of the public may address the Board for a maximum of three minutes on items not on the current agenda, for a collective total of fifteen minutes.  
Members of the public will speak on agenda items after comments are called for by the presiding officer, but before Board discussion and consideration of the item. Individuals of the public may address the board for a maximum of three minutes per person per agenda item, for a collective amount of fifteen minutes per agenda item;
3. Discuss and consider action on minutes of the July 14, 2021 Regular meeting and the August 4, 2021 Budget workshop and Special meeting;
4. Discuss and consider action on treasurer's report, including the payment of invoices, reimbursements, and status of District's deposit of funds; (C. Sisk)
5. Consider taking action regarding extension and/or revisions to service provider contract;
6. Consider taking action regarding FY 2021-2022 budget;
7. Discuss and consider taking action regarding 2021 tax rate, including;
  - a) Establishing proposed tax rate;
  - b) Taking record vote and scheduling public hearing;
  - c) Authorizing publication of "Notice of Public Hearing on Tax Increase" in *Hays Free Press* and *San Marcos Daily Record*; and
  - d) Acknowledging and approving posting of Notice About 2021 Tax Rates and "Notice of Public Hearing on Tax Increase" to home page of District website;
8. Receive monthly report from SMHCEMS regarding emergency operations, response times, call volume, training, management activities, and membership; (D. Smith, J. Swisher, M. Weinberg);
9. Discuss time, place, date, and agenda items for next meeting; and
10. Adjourn.
