Notice is hereby given that a meeting of the Board of Commissioners of Hays County Emergency Services District No. 9 will be held on **October 14, 2020 at 6:30 p.m.**, at Kyle Fire Department Station No. 1, 210 W. Moore St., Kyle, Tx 78640.


Due to the state of emergency and/or local disaster caused by the COVID-19 pandemic, the Board of Commissioners of Hays County Emergency Services District No. 9 may hold its meeting via telephone conference call because of the difficulty and risks of convening a quorum in one location. If initiated, the call will be broadcast at the meeting location and recorded as required by the Texas Open Meetings Act. - 1. Call to order; establish quorum;
- 2. Public Comment; In accordance with the Texas Attorney General’s opinion, any public comment that is made on an item that is not on the published final agenda will only be heard by the Board of Commissioners. No formal action, discussion, deliberation, nor comment will be made by the Board of Commissioners. Individual members of the public may speak address the board for a maximum of three minutes on items not on the current agenda, for a collective total of fifteen minutes.

Members of the public will speak on agenda items after comments are called for by the presiding officer, but before Board discussion and consideration of the item. Individuals of the public may address the board for a maximum of three minutes per person per agenda item, for a collective amount of fifteen minutes per agenda item;

- 3. Discuss and consider action on minutes of the September 9, 2020 meeting;
- 4. Discuss and consider action on treasurer’s report, including the payment of invoices, reimbursements, and status of District’s deposit of funds;
- 5. Review and approve the quarterly investment report for 4th quarter;
- 6. Discuss and consider engagement of an auditor to perform the following year audit;
- 7. Receive monthly report from Chief Smith with SMHCEMS regarding emergency operations, response times, call volume, training, management activities, and membership;
- 8. Discuss required training hours for Commissioners;
- 9. Discuss and consider attendance at Texas State Association of Fire and Emergency Services District (SAFE-D) Annual Conference, to be held February 18-20, 2021 at the Fort Worth Convention Center, Fort Worth, Texas;
- 10. Discuss time, place, date, and agenda items for next meeting; and
- 11. Adjourn.
