No formal action, discussion, deliberation, nor comment will be made by the Board of Commissioners. Individual members of the public may speak address the board for a maximum of three minutes on items not on the current agenda, for a collective total of fifteen minutes.

Members of the public will speak on agenda items after comments are called for by the presiding officer, but before Board discussion and consideration of the item. Individuals of the public may address the board for a maximum of three minutes per person per agenda item, for a collective amount of fifteen minutes per agenda item;

- 4. Discuss and consider action on treasurer’s report, including the payment of invoices, reimbursements, and status of District’s deposit of funds;
- 5. Consider taking action regarding revised FY 22-23 budget;
- 6. Receive monthly report from Chief Smith with SMHCEMS regarding emergency operations, response times, call volume, training, management activities, and membership;
- 7. Discuss time, place, date, and agenda items for next meeting; and
- 8. Adjourn.
