Individual members of the public may address the board for a maximum of three minutes on items not on the current agenda, for a collective total of fifteen minutes.

Members of the public will speak on agenda items after comments are called for by the presiding officer, but before Board discussion and consideration of the item. Individuals of the public may address the board for a maximum of three minutes per person per agenda item, for a collective amount of fifteen minutes per agenda item;

- 9. Discuss and consider attending the Annual SAFE-D Conference, scheduled for February 22-24, 2024, at the Irving Convention Center;
- 10. Discuss and consider Commissioner updates;
- 11. Discuss meeting of ESD5 and ESD9 subcommittee regarding EMS residency and buildout of KFD station #4 and take action if necessary;
- 12. Discuss and consider action regarding subcommittee report on strategic planning and agreements for providing EMS between North Hays ESD1 and Hays ESD9;
- 13. Discuss time, place, date, and agenda items for next meeting; and
